

## DFS PHL Approved Swabs for SARS-CoV-2 Testing





The following swabs have been validated and approved to use for SARS-CoV-2 testing at the DC DFS Public Health Laboratory. **Please Note**: Calcium alginate swabs are unacceptable and swabs with cotton tips and wooden shafts are not recommended.

**Please note:** All specimens collected for molecular testing must be refrigerated (2-8°C) promptly after collection and couriered/shipped on cold packs within 72 hours. Specimens being held for >72 hours must be stored at -70°C and couriered/shipped on dry ice. Please do not freeze specimens if courier pick up will occur within 24 hours. It is very important that you contact DFS-COVID19@dc.gov as soon as the specimen is collected so that a courier can be ordered to pick up the specimen.
